LAKE COUNTY HOLDS RALLY FOR SOCIAL JUSTICE

The Lake County community wanted to share solidarity with the Black Lives Matter movement.

On Monday, June 8th, a gathering of approximately eighty (80) black, brown and white people came to the entrance to Idlewild at the corner of US-10 and Broadway Avenue at 4:00 p.m. to show support for the need for social justice.

"Idlewild, Lake County, MI is the right place for this rally because it has been a place of refuge from racism for

decades", stated Mary L. Trucks. Executive Director of the local Commu-Action nity Agency, FiveCAP, Inc. "First, I want to thank Mrs. Mildred Kyles, the organizer. She knew we needed this space to gather, stand and speak up for change. This is a peaceful demonstration for people of all races, black and white, to speak out against institutional racism."

Recognition was given to those who have been killed because of the color of their skin. The names of George Floyd

and many others were listed off, followed by an emotional 8 minutes of silence in remembrance of Mr. Floyd. Quotes were recited from Dr. Martin Luther King, "The time is always right to do what is right." and Dr. Angela Davis, "In a racist society, it is not enough to be non-racist, we must be anti-racist".

The peaceful gathering continued into the early evening to show solidarity with fellow Americans all over this nation and righteous people all over the world, calling for an end to racism and justice for ALL!

Back-to-back June food distributions with 1,851 food boxes to low-income seniors and families

FiveCAP staff and volunteers banded together, wearing masks, gloves and social distancing, packing and distributing 1,851 food boxes via curbside pick-up in Mason, Manistee, Lake and Newaygo counties.

FiveCAP held its quarterly food distribution of The Emergency Food Assistance Program (TEFAP) on June 4th. This program provides food every three months to incomeligible households. TEFAP is open to residents of all ages to help them extend their already stretched budget by providing nutritious foods.

On June 10th, Commodity Supplemental Food Program (CSFP) food boxes were distributed. This distribution program is every two months. It is designed to supplement the diets of low-income seniors, 60 and older, a demographic that is most often living on a limited and fixed income. Good nutrition sometimes takes a backseat to other expenses like utilities and medications. These boxes provide some of the staples from each food group.

In support of providing healthy eating habits and cost savings by growing foods, FiveCAP offers gardening and food preservation workshops annually. To start their garden, each participant receives a variety of vegetable plants. This year,

due to COVID-19 and the Stay-at-Home Order, the gardening workshops in May were cancelled, however plants and handouts from MSU Master Gardeners were given out during the CSFP food distribution.



Coronavirus Aid, Relief, and Economic Security (CARES) Act funding to help area residents

\$334,826 in additional funding for FiveCAP Head Start Program

These funds will support FiveCAP Head Start services in Mason, Manistee, Lake and Newaygo counties, Michigan.

Nationally, \$750 million has been designated for Head Start programs to support preventative, prepared-



ness, and response activities related to the coronavirus through the CARES Act. Funds have been released directly to all 1,600 local Head Start and Early Head Start programs, including tribal programs, in every state and territory.

"We know that investing in programs that use a whole family approach to learning and development can be pivotal to the success of children and families," said Lynn Johnson, assistant secretary for the Administration for Children and Families. "During this pandemic, it is important to support programs that enrich and enlighten children, families, and communities as they work towards their goals and make concentrated efforts to improve their future post the pandemic."

The FiveCAP, Inc. Head Start program will use the CARES Act funding to provide critical support to enrolled children and families. "During this crisis, we have been able to provide crisis response to our Head Start families, including meals, mental wellness support, and connection to community resources," said Mary L. Trucks, Executive/Head Start Director. "We have also trained all of our staff in infectious disease management as we prepare to reopen our classrooms in the fall.



FiveCAP receives \$411,345 in Community Services Block Grant CARES funding!

CSBG CARES—The impact of increased unemployment will cause a future increase in demand for basic needs assistance, such as food, shelter, transportation and general well-being needs. There is also the threat of the continuing pandemic and reoccurrence.

In response, prevention and intervention efforts are being taken to address needs for critical resources.

FiveCAP has enhanced food pantries and quarantine packages (Q-Packages) available including food and sanitization supplies. We are working with the local District #10 Health Departments to distribute packages to those quarantined or affected by COVID-19.

In preparation, our County FiveCAP Offices are increasing refrigeration/freezer space to include more items, and will stock personal hygiene items and cleaning supplies.

CARES funds will be used to expand services for housing assistance, vehicle repair assistance (one-time, with a \$500 cap), insurance, appliance repair or replacement, and more.

FiveCAP Head Start enrolling and preparing for 2020/2021 program year

FiveCAP Head Start Center Directors and Teachers are attending trainings and preparing the Centers for special temporary protocols being implemented due to COVID-19, and reaching out to enroll children for the upcoming program year anticipated



to begin after the Labor Day weekend. Lobbies are closed, except by appointment only.

FiveCAP, Inc. is committed to protecting the health of our children, families, and community. Policies were designed in response to guidance from the Michigan Department of Licensing and Regulatory Affairs (LARA) and Health and Human Services, in accordance with best practices from the Centers for Disease Control and Prevention. To limit the potential spread of COVID-19, temporary changes to our programming include robust cleaning and disinfecting procedures and minimizing opportunities for person-to-person exposure.

The plan outlines the recommended practices and strategies we will use to protect the health of our children, staff, and families while at the same time ensuring that children are experiencing developmentally appropriate and responsive interactions and environments.


"Working remotely was a learning experience for us", stated Mary L. Trucks, Executive/Head Start Director. "With little notice, we had to adapt quickly. Our Center Directors and teaching staff stepped up to keep in contact with families and provide services at a distance."

Based on our experience, staff feedback, and guidance, a formal Remote Education Plan has been outlined in the event of another shut-down so that staff and parents maintain continuous interaction and that there is no lapse in services and resources to families. The Remote Education Plan includes a Continuous Learning Plan for Access, Methodologies, and Technology Needs, Communication Plan, and Resources, with detailed instruction for staff to follow if remote services are necessary.

We are striving to be the safest possible workplace and service facility for our staff, clients and guests. To ensure a clean and safe experience for all!

Here are a few steps we have taken to make this happen:

Daily health check-ins

Single occupancy restrooms

Over a half MILLION \$ in tax return refunds to low-income residents

COVID-19 may change the way we are operating, but it has not stopped services. Face-to-face appointments were suspended for most of the tax season, but free tax preparation and e-filing assistance was provided by phone with documents mailed, faxed, emailed or dropped off.

As of July 10th, FiveCAP assisted 634 lowincome residents reign in \$530,000 in tax refund dollars.

This is money infused right back into our local economy. Many people depend on this money to catch up on their bills, help pay some of the high cost of heating their homes through the winter and purchase essential items for their households.

The IRS and State filing deadline was extended to July 15th, however residents still have time to claim tax credits if they haven't filed a tax return yet. Residents are reminded that the deadline for the home heating credit isn't until September 30. FiveCAP encourages anyone who hasn't filed yet, to make an appointment to have your taxes prepared. Even though tax day will pass, there are other credits that residents may qualify to receive.

To make an appointment, contact your county FiveCAP office.

Idlewild Historic & Cultural Center closed for summer 2020 due to COVID-19

Established in 2003, the Idlewild Historic & Cultural Center provides a location where the many people who are fascinated by the historic community can learn more about what makes Idlewild an important piece of American history.

Before the Civil Rights Act of 1964, this resort community in the woods of northern Michigan was one of the few places in the U.S. where African Americans could simultaneously escape city life and segregation. They could freely enjoy the sparkle of starlight, the shimmer of the lakes and the right to own property.
