
FiveCAP Executive Director attends 2023 Congressional Civil Rights Pilgrimage to Alabama



Mary L. Trucks (FiveCAP Executive Director) and Deborah Smith-Olson (Lake Osceola State Bank-Chair) were special constituent guests of Congressman John Moolenaar to participate in The Faith & Politics Institute, Congressional Civil Rights Pilgrimage to Birmingham, Selma, and Montgomery, Alabama on March 3-5, 2023. The itinerary included a gathering for the Selma Bridge Crossing Jubilee and commemoration of the 58th anniversary of Bloody Sunday.

"It confirmed my personal memories of experiences growing up in segregated Mississippi. I found it to be educational by placing events into historical context.", stated Mary L. Trucks. "The trip was a great networking opportunity. I was able to meet and engage with members of Congress, corporate sponsors, and academics. We had discussions about Community Action and how the Civil Rights Movement gave rise to the national anti-poverty initiatives that continue today."

People who are experiencing hardship, loss of employment or underemployment, or are on a fixed income and legitimately unable to meet the necessary payment of their utility bills, may receive assistance with Walk for Warmth funds.

Funds are allocated to help people in the county they are raised.

Head Start & Early Head Start GRANT PLANNING



On March 17th, Head Start and Early Head Start staff and management, Board, Policy Council, and community partners gathered together for an intensive review of FiveCAP Head Start/Early Head Start Service Plans.

Participants broke into groups for an in-depth review of the Head Start Performance Standards with discussion of FiveCAP program goals, strengths and weaknesses in each of the following topic areas: Eligibility, Recruitment, Selection, Enrollment, and Attendance (ERSEA); Education; Family & Community Engagement; Facilities; Early Head Start; Transition Services; Disabilities; and Health Program Services.

The outcome of this annual Grant Planning event, provides a summary of strengths and weaknesses, and recommendations used to develop next year's program goals and objectives to be included in our continuation grant application for FY 2023/2024 which will be due in August 2023.



Mason Co. Emergency Home Repair assistance for wells/ septics and roofs

The Mason County Emergency Repair Program is a deferred (forgivable) payment loan to eligible homeowners for home repairs.

Eligible repairs include furnace, well/septic, plumbing, drain system hook-up, handicap ramps, electrical, or roof repair/replacement. All other items will be considered. Contractors must be licensed and insured.

Deferred loans will only have to be repaid if the homeowner refinances or sells the home, or upon transfer or ownership convenance (voluntary or involuntary). The possibility of loan deferral continuation may be allowed if heirs are income eligible and reside in property as a principal residence.

Approval of services is based on CDBG program eligibility criteria (80% of Area Median Income), health and safety, and cost effectiveness of service. All awards must be approved by the Mason County Review Board.
