It's that time of year again when we need to begin planning for Preschool 2022-2023. If you have a child who is currently 3 or 4 years old, he/she may be eligible for Head Start (3 or 4 years old by September 1, 2022), or Great Start Readiness Program (4 years old by September 1, 2022).

The application is on the back of this letter. Please fill it out and return it to our school office. Once we have your application, you will be contacted by a Head Start or Great Start staff member. They will make an appointment to meet with you and your child at your convenience. This will begin the process of determining whether your child is eligible for either of the above mentioned programs. Final enrollment determinations are made by our Great Start Readiness Program Staff and/or Head Start Staff. Letters regarding enrollment will be sent out after July 1, 2022.
