

Who Benefits From “Walk for Warmth”?

People who are low-income, have experienced loss of employment or under-employment, are on a fixed income, have felt a rise in prices, and/or loss of economic opportunity, and are legitimately unable to meet basic payment of their utility bills, may receive assistance with Walk for Warmth funds. These individuals by their status, are or are near to being homeless.

Prior to assistance, individual must have been denied help in writing by the Michigan Department of Health & Human Services (MDHHS).

People who volunteer, pledge, and/or walk receive the satisfaction of knowing that they are helping individuals and families in need from their county.

Local companies who support, sponsor, or help in this effort will receive tax benefits and publicity.

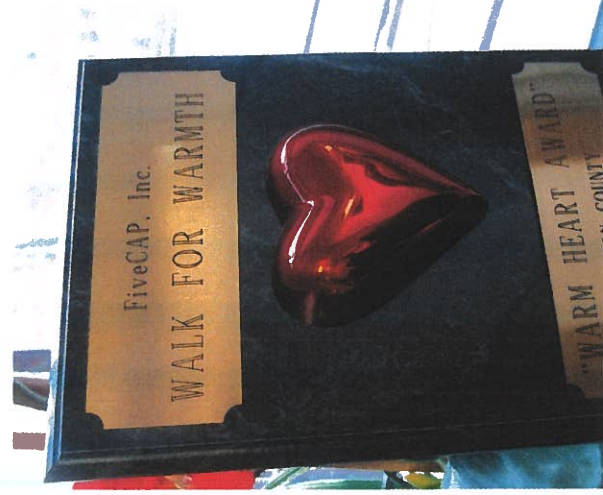
